


Agenda: Reforming the United Nations Security Council Expansion or Efficiency?



Historical Background of the UNSC

The United Nations Security Council (UNSC) was established in 1945 in the aftermath of the Second World War with the primary responsibility of maintaining international peace and security. Its structure reflects the geopolitical realities of that period, comprising five permanent members—China, France, Russia, the United Kingdom, and the United States—endowed with veto power, and ten non-permanent members elected for two-year terms. This arrangement was designed to

ensure collective security through cooperation among the major powers of the time. While the UNSC has played a critical role in conflict resolution, peacekeeping, and sanctions regimes, its foundational framework has remained largely unchanged despite significant shifts in global power dynamics.

Need for Reform: Global Perspectives

Over the decades, the international community has increasingly questioned the representativeness and legitimacy of the Security Council. Many regions, particularly Africa, Latin America, and parts of Asia, remain underrepresented in permanent decision-making structures despite their growing political and economic influence. Developing nations argue that the current composition undermines the democratic ethos of the United Nations and limits the Council's credibility. Conversely, some Member States emphasize stability and caution against reforms that could weaken the Council's authority or operational coherence. These divergent global perspectives underscore the complexity of achieving consensus on reform while balancing equity, legitimacy, and effectiveness.

Expansion vs. Efficiency: Key Arguments

The debate on UNSC reform often centres on two primary approaches. Advocates of expansion argue that increasing permanent and/or non-permanent membership would make the Council more representative of contemporary global realities, enhance regional inclusivity, and strengthen the legitimacy of its decisions. Proposals include adding new permanent members, introducing long-term elected seats, or increasing representation for developing regions.

On the other hand, proponents of efficiency caution that expansion may lead to slower decision-making, reduced consensus, and institutional gridlock.

They argue that reforms should instead focus on improving working methods, increasing transparency, limiting the use of the veto, and enhancing cooperation with the General Assembly. This school of thought prioritizes timely action and operational effectiveness over structural enlargement.



Contemporary Challenges in Global Governance

The Security Council today confronts complex and evolving challenges, including protracted conflicts, terrorism, cyber threats, climate-related security risks, humanitarian crises, and geopolitical rivalries among major powers. Increasing use of the veto, selective enforcement of resolutions, and accusations of politicization have further strained the Council's credibility. In an era marked by multipolarity and interdependence, the UNSC must adapt to ensure relevance, accountability, and responsiveness.

Through this agenda, delegates are tasked with proposing balanced and pragmatic reforms that address these challenges while strengthening multilateral cooperation and advancing the principles of peace, justice, and strong institutions embodied in SDG 16.

Recent Developments Related to the Agenda

1. Renewed Push for Structural Reform

In 2025, the UN Secretary-General renewed calls for Security Council reform, emphasizing expansion to reflect current geopolitical realities and address the underrepresentation of regions such as Africa. Parallel discussions in the General Assembly have reinforced the urgency of adapting the Council to modern global challenges.

2. General Assembly Demands Veto Overhaul

Growing frustration over repeated deadlocks—particularly on conflicts such as Ukraine and Gaza—has led many Member States to demand restraint and reform of the veto mechanism, arguing that unchecked veto use undermines accountability and effectiveness.

3. Global South & Regional Perspectives

Countries and regional blocs continue to advance distinct reform visions. India supports equitable regional representation, Africa seeks permanent seats, and several Asian and European states advocate for more inclusive global governance—highlighting diverse priorities within the reform debate.

4. Incremental Reform Pathways


Given the difficulty of amending the UN Charter, focus has shifted toward procedural and functional reforms, including improved working methods and a stronger General Assembly role when the Council is blocked.

5. Elections & Representation

Upcoming elections in June 2026 for non-permanent Security Council seats sustain debates on legitimacy and inclusivity, increasing visibility for underrepresented states despite the absence of veto power.

3 THE COMMITTEE PROCEEDINGS

The committee proceedings at Unique Bureaucrats MUN follow a structured and sequential debate flow designed to mirror authentic United Nations deliberations. Each stage plays a critical role in ensuring orderly discussion, meaningful negotiation, and effective decision-making.



1. Roll Call

The session formally begins with Roll Call, during which delegations are marked present or present and voting. This establishes quorum and confirms the committee's readiness to proceed with formal debate.

2. Position Paper Submission

Delegates submit their position papers outlining national policies, priorities, and perspectives on the agenda. These documents demonstrate research depth, policy understanding, and preparedness, and serve as a foundation for substantive debate.

3. General Speakers' List (GSL)

The General Speakers' List sets the tone of the committee. Delegates deliver formal opening statements, articulate national stances, and introduce key concerns and objectives. The GSL remains open throughout debate unless formally closed.

4. Bloc Formation & Negotiations

Delegates engage in informal discussions to identify shared interests and form blocs. This stage emphasizes coalition-building, diplomatic engagement, and alignment of policy objectives across delegations.

5. Resolution Drafting

Working groups translate negotiations into written form by drafting clauses that propose concrete solutions. This stage tests delegates' policy clarity, legal precision, and ability to convert ideas into actionable international commitments.

6. Resolution Presentation

Approved draft resolutions are formally introduced to the committee. Sponsors explain the intent, structure, and key operative clauses, allowing the committee to understand the proposed framework before debate continues.

7. Cross-Bloc Scrutiny Session

Draft resolutions are examined critically by other blocs and delegations. Delegates question feasibility, legality, and political implications, ensuring rigorous review and strengthening the quality of proposed solutions.

8. Amending Resolutions

Delegates propose amendments to refine, clarify, or modify draft resolutions. Both friendly and unfriendly amendments are considered in accordance with procedural rules, reflecting negotiation, compromise, and adaptability.

9. Final Bloc Presentation

Blocs present their finalized resolutions, highlighting revisions, consensus achieved, and anticipated impact. This stage emphasizes persuasion, clarity, and diplomatic confidence prior to voting.

10. Voting Session

The committee enters voting procedure to determine the adoption of draft resolutions. Each Member State casts one vote, and decisions are finalized in accordance with UNGA voting rules, marking the culmination of the committee's work.

This structured debate flow reflects the discipline, precision, and deliberative rigor of the United Nations system. By guiding delegates through each stage of policy articulation, negotiation, and decision-making, it ensures a realistic diplomatic experience that cultivates strategic thinking, consensus-building, and leadership. Ultimately, the process equips delegates with the competence, confidence, and professional acumen required for meaningful engagement in real-world multilateral diplomacy.

RULES OF PROCEDURE

The following Rules of Procedure govern all formal sessions of the United Nations General Assembly at the Unique Bureaucrats Model United Nations Conference, Jaipur 2026. These rules are derived from standard United Nations parliamentary practice and are binding on all delegates. Adherence ensures order, fairness, and procedural integrity throughout the conference.

I. General Rules

- The official working language of the conference shall be English.
- All delegates must address the Chair in the third person and refer to themselves and others by their country or official designation, not by personal names.
- Decorum must be maintained at all times. Delegates shall conduct themselves with professionalism, respect, and diplomatic courtesy.
- The authority of the Executive Board is final in all procedural matters. Any interpretation of the rules by the Chair shall be binding.
- Electronic devices may be used strictly for research purposes unless otherwise prohibited by the Executive Board.
- Delegates must remain within the scope of the committee mandate and refrain from using offensive, inflammatory, or unparliamentary language.
- Attendance is mandatory for all formal sessions. Repeated absence may result in disciplinary action or disqualification from awards.
- Delegates are expected to wear Western Business Formals or National Attire that reflects professional diplomatic standards.



II. UNGA Rules of Procedure

- The United Nations General Assembly operates on the principle of sovereign equality of all Member States; each delegation holds one vote.
- Debate shall be conducted through formal sessions, including the General Speakers' List, moderated caucuses, and unmoderated caucuses.
- The General Speakers' List (GSL) shall be open at all times unless temporarily closed by a procedural motion.
- Speaking time for delegates shall be determined by the Executive Board and may be adjusted at its discretion.
- Delegates may yield their remaining time to the Chair, to another delegation, or to questions, subject to the Chair's approval.

- Draft resolutions must be formally introduced, debated, amended where necessary, and voted upon according to UNGA procedure.
- The Chair reserves the right to rule any motion or proposal dilatory, out of order, or repetitive.

III. Points & Motions Explained

Points are used to address procedural or substantive concerns and may interrupt a speaker only when explicitly permitted.

- **Point of Personal Privilege:** Raised to address personal discomfort impairing participation (e.g., audibility, temperature). May interrupt a speaker.
- **Point of Order:** Raised to question the correct application of the Rules of Procedure. Cannot interrupt a speech unless there is a procedural error.
- **Point of Parliamentary Inquiry:** Raised to request clarification regarding the Rules of Procedure. Must not interrupt a speaker.

Motions are formal proposals that structure the flow of debate and require the Chair's recognition.

- **Motion to Set the Agenda:** Establishes the order of discussion where applicable.
- **Motion for a Moderated Caucus:** Proposes a focused discussion on a specific sub-topic with a defined speaking time.
- **Motion for an Unmoderated Caucus:** Allows informal negotiation and collaboration among delegations.
- **Motion to Close Debate:** Moves the committee into voting procedure. Requires a two-thirds majority.
- **Motion to Suspend the Meeting:** Used for breaks or adjournment between sessions.
- **Motion to Adjourn the Meeting:** Ends the final session of the committee.

IV. Voting Procedures

- Once debate has been formally closed, the committee shall enter Voting Procedure, during which no interruptions are permitted except for Points of Order related to voting.
- Only substantive matters, including draft resolutions and amendments, shall be voted upon. Procedural motions do not require voting once ruled in order by the Chair.
- Voting shall be conducted by placard unless a roll-call vote is requested and approved.
- Each delegation may vote In Favour, Against, or Abstain, unless otherwise specified.
- A simple majority is required for the adoption of resolutions and amendments in the UNGA unless stated otherwise.
- Delegations may not abstain on procedural matters.
- The Chair shall announce the results of the vote, which shall be final and recorded in the committee proceedings.

These Rules of Procedure are designed to uphold the integrity, realism, and diplomatic excellence of the Unique Bureaucrats MUN Jaipur 2026. Delegates are strongly encouraged to master these rules to participate effectively and uphold the highest standards of Model United Nations diplomacy.

5 DELEGATE PREPARATION GUIDE

Preparing for Model United Nations is more than completing assignments; it's about thinking like a diplomat, engaging with global challenges, and communicating with precision, integrity, and influence. The more thoroughly you prepare, the more powerfully you will contribute to debate — and the greater the impact you will make in your future global career.



1. Research Methodology

Effective preparation begins with strategic, disciplined research. A delegate's credibility and influence in committee depend on deep subject-matter knowledge, contextual insight, and the ability to integrate data with diplomatic reasoning.

Start with the basics:

- Understand the topic's context and history — review UN reports, resolutions, treaties, and relevant international agreements.
- Study your assigned country's foreign policy, historical positions, and voting patterns related to the issue.
- Use reputable sources such as official UN documents, academic journals, government statements, and global think-tanks.

- Organize research thematically: Background, Past International Actions, National Policy, and Potential Solutions.

Research tips:

- Prepare a Research Binder or digital folder with key documents, charts, and summaries to reference during committee sessions.
- Distinguish fact from opinion, and annotate sources to defend your positions with authority.
- Anticipate other country viewpoints — identifying allies and opposition strengthens negotiation strategy.

2. Position Paper Guidelines

A Position Paper distills your research into a succinct statement of your country's stance. At the United Nations, position documents shape debate and demonstrate your delegate competence.

Core Purpose:

- Articulate your country's understanding of the issue.
- Display how the issue affects your nation.
- Present clear, actionable policy goals and proposed paths forward.

Structure:

1. Introduction: A concise thesis stating your country's overall position.
2. Background & Past International Actions: Historical context and relevant

UN actions or treaties.

- Country Policy & Perspective: Your nation's policy rationale, supported by evidence and official sources.
- Proposed Solutions: Realistic, committee-oriented resolutions your country supports.

Key principles:

- Be clear, concise, and evidence-based — avoid verbosity.
- Cite authoritative sources (e.g., UN charters, national statements, treaties).
- Submit on time and conform to formatting and length requirements set by the conference. (Max. word limit is 600 words ; Font - Times New Roman)

3. Draft Resolution Writing

Draft resolutions are the culmination of negotiation, collaboration, and diplomatic articulation. They translate debate into actionable policy recommendations that the committee may adopt.

Resolution Anatomy:

- Heading: Includes committee name, sponsors, and signatories.
- Preambulatory Clauses: Provide context, citing past UN decisions, and explain why the issue matters.
- Operative Clauses: Recommend specific actions or measures that the committee should take.

Best practices:

- Collaborate early — forming blocs and co-sponsorship increases chances of passage.
- Ensure preambular clauses logically justify proposed solutions.
- Operative clauses must be clear, specific, and feasible — answering "who," "what," and "how."
- Use formal diplomatic phrasing and maintain consistency in layout and punctuation.

4. Speech & Debate Techniques

Confident delivery and persuasive argumentation are essential to influence committee outcomes and build consensus. United Nations

Before You Speak:

- Plan interventions that are relevant, succinct, and strategically timed.
- Reference your position paper to ensure consistency and credibility.

During Debate:

- Address the Chair respectfully and adhere strictly to speaking protocols.
- Frame speeches to clarify your country's priorities, outline solutions, and respond constructively to others' points.
- Use facts and figures judiciously — support assertions with verifiable evidence.

Negotiation & Collaboration:

- Engage others during unmoderated caucuses to refine resolution text and build alliances.
- Be articulate but open to compromise — consensus is the core strength of multilateral diplomacy.

The United Nations Security Council (UNSC) stands at the core of the international peace and security architecture. While its authority remains unparalleled, its structural design—largely unchanged since 1945—has increasingly been called into question. Country XYZ asserts that the credibility and effectiveness of the UNSC are contingent upon its ability to reflect present-day geopolitical realities while maintaining decisional efficiency. In alignment with Sustainable Development Goal 16, XYZ advocates for reform that strengthens institutional legitimacy, accountability, and responsiveness without undermining the Council’s operational capacity.

Structural Imbalance and the Case for Reform

Country XYZ notes that the UNSC’s current composition fails to adequately represent the demographic, political, and economic shifts that have occurred over the past eight decades. Entire regions remain structurally underrepresented, despite bearing the disproportionate consequences of UNSC decisions. This disconnect weakens confidence in multilateral decision-making and challenges the principle of sovereign equality enshrined in the UN Charter.

XYZ recognizes that reform is both politically sensitive and procedurally complex. Nevertheless, the absence of reform risks rendering the Council increasingly ineffective and detached from the realities it seeks to govern.

Expansion as a Means to Enhance Legitimacy

Country XYZ supports a calibrated expansion of the UNSC, encompassing both permanent and non-permanent categories, with particular emphasis on equitable regional representation. Such expansion should be guided by objective criteria, including contribution to international peacekeeping, commitment to multilateralism, and adherence to international law.

XYZ cautions, however, that expansion must not be pursued solely as a symbolic gesture. Without complementary procedural reforms, an enlarged Council risks exacerbating inefficiencies and diluting responsibility. Therefore, expansion must be accompanied by institutional safeguards to preserve decisional coherence.

Efficiency, Veto Power, and Institutional Accountability

Efficiency remains a central concern for Country XYZ. The inability of the UNSC to act decisively in the face of humanitarian crises has often stemmed not from a lack of authority, but from political deadlock—particularly related to the use of the veto.

While acknowledging the political realities surrounding veto reform, XYZ strongly supports voluntary veto restraint in situations involving mass atrocities, war crimes, and crimes against humanity. Such restraint would represent a meaningful step toward aligning the Council's actions with international humanitarian norms and the preventive ethos of SDG 16.

Furthermore, XYZ advocates for enhanced transparency in UNSC deliberations, including improved communication with the General Assembly and affected Member States. Strengthening this relationship would ensure broader accountability while maintaining the UNSC's primary mandate.

UNSC Reform and SDG 16

SDG 16 calls for the development of effective, accountable, and inclusive institutions at all levels. UNSC reform is inseparable from this objective. A Council that is both representative and efficient is better equipped to prevent conflict, uphold justice, and reinforce the rule of law. Country XYZ emphasizes that preventive diplomacy and institutional legitimacy are cost-effective and sustainable alternatives to reactive crisis management.

Conclusion

Country XYZ maintains that the dichotomy between expansion and efficiency presents a false choice. Sustainable reform must integrate both dimensions through pragmatic compromise and political will. By modernizing its structure while strengthening its procedures, the UNSC can reaffirm its central role in global governance. XYZ urges Member States to approach reform negotiations not through narrow national interests, but through a shared commitment to peace, justice, and strong institutions for future generations.

Honourable Chair, distinguished delegates,

The delegation of XYZ believes that the debate on Security Council reform is no longer theoretical—it is institutional and urgent. An organ designed for the geopolitical realities of 1945 cannot credibly govern the security challenges of the 21st century.

XYZ asserts that legitimacy and efficiency are not competing priorities, but mutually reinforcing imperatives. A Council that lacks representative balance will continue to face questions of credibility, while a Council paralysed by political deadlock will fail its primary mandate of maintaining international peace and security.

In alignment with SDG 16, XYZ advocates a calibrated expansion of the Council, paired with procedural reforms that enhance transparency, accountability, and responsible decision-making—particularly regarding the use of the veto in situations of mass atrocities.

The question before this Assembly is not whether reform is necessary, but whether we possess the political will to modernize multilateralism without weakening it. XYZ stands ready to engage constructively toward a Security Council that is representative in composition, efficient in action, and legitimate in authority.

The United Nations General Assembly,

Recalling the purposes and principles of the Charter of the United Nations, particularly Article 24, which entrusts the United Nations Security Council with the primary responsibility for the maintenance of international peace and security,

Reaffirming its commitment to Sustainable Development Goal 16, which calls for peaceful and inclusive societies, access to justice, and effective, accountable, and inclusive institutions,

Recognizing that the composition and working methods of the United Nations Security Council reflect the geopolitical realities of 1945 rather than the contemporary international system,

Acknowledging growing concerns among Member States regarding the representational imbalance and procedural inefficiencies within the Security Council,

Noting with concern instances where prolonged political deadlock within the Security Council has hindered timely responses to conflicts, humanitarian crises, and mass atrocities,

Emphasizing that reform of the Security Council is essential to restoring trust in multilateralism and strengthening global governance,

1. Calls for a balanced and comprehensive reform of the United Nations Security Council that simultaneously addresses issues of representational equity and operational efficiency;

2. Supports the measured expansion of the Security Council, including:

- a. An increase in both permanent and non-permanent seats,
- b. Equitable regional representation, particularly for underrepresented regions,
- c. Transparent criteria for new members based on commitment to international peace, multilateral cooperation, and the rule of law;

3. Recommends that any expansion of membership be accompanied by procedural safeguards to prevent decision-making paralysis, including structured debate timelines and improved agenda-setting mechanisms;

4. Encourages permanent members of the Security Council to exercise voluntary restraint in the use of the veto in situations involving genocide, war crimes, crimes against humanity, and large-scale humanitarian crises;

5. Calls for enhanced transparency and accountability within the Security Council through:

- a. Regular briefings to the General Assembly,
- b. Increased use of open debates,
- c. Greater engagement with affected Member States and organizations;

- 6. Urges strengthened coordination between the Security Council and the General Assembly to ensure broader consultation while respecting the distinct mandates of each organ;**
- 7. Supports capacity-building initiatives aimed at improving preventive diplomacy, early warning mechanisms, and conflict resolution in line with the objectives of SDG 16;**
- 8. Encourages continued intergovernmental negotiations on Security Council reform, emphasizing consensus-building, inclusivity, and political compromise;**
- 9. Requests the Secretary-General to submit periodic reports to the General Assembly on progress made toward enhancing the effectiveness, representativeness, and accountability of the Security Council;**
- 10. Decides to remain actively seized of the matter.**
